# **Return Policy**

#### All Returns:

- Must be authorized and assigned a Return Goods Authorization (RGA#)
- Must have the RGA# visible on the returned package
- Will be charged a 25% restocking fee
- There will be no returns after 30 days

#### **Product Must Be:**

- In quality saleable condition
- In original packaging

# **Defective or Damaged Product:**

- Follow guidelines for obtaining RGA#
- Credit issued upon receipt and inspection of product
- No restocking fee will apply
- For damaged product due to shipping, please make claim with parcel carrier

### **Credit Request**

### **Incorrect Pricing or Short Shipments:**

- Must be reported within 10 days to ensure the proper credit is issued to the account
- Please do not deduct incorrect pricing or short shipments from your payment without a credit

#### Orders Placed in Error:

- RGA# must be obtained
- 25% restocking charge will appear on credit

### **Shipping Errors:**

- Must be reported within 10 days of receipt
- Returned with an RGA#
- Credit will be issued upon receipt of this product, please do not deduct from your payment
